In this litigious age comprehensive Club Liability insurance is essential and MEAD include

- ▶ **Public and Products Liability** insurance to cover the potential Liabilities of The Club and/or its Officers, in the event that it or they stand accused of an act of Negligence that has led to Injury to a Third Party or Damage to their Property, proven in the eyes of the Law. Cover given to a Limit of Liability any one incident, of **£5,000,000**. Excess £1000 only applicable to Third Party Property Damage claims.
- ▶ **Employers Liability** insurance to cater for Clubs who employ or have Volunteers that carry out work on behalf of The Club or use Work Experience Youngsters and/or have Employees such as Bailiffs, based on a maximum Club annual Wage Roll of £9,000. Cover given to a Limit of Liability of **£10,000,000**
- ▶ **Directors and Officers Liability** insurance in the event of proven failure to carry out executive duties adequately. Limit of Liability **£500,000** in the aggregate over the 12 months of the policy. Written on a Claims Made basis and to include Trustees.
- ▶ **Worldwide Personal Liability** insurance for all Individual Members of Clubs, in the event that they are accused of causing Third Party Injury or Property Damage, whilst fishing anywhere any time thus being operative during all social fishing activities as well as Club fishing. Cover given to Juniors under 16 as the perpetrator of an act of negligence only if they are accompanied at the time of the incident. No embargo on Juniors fishing on their own and of course they will be covered as a Third Party if they are the victim of a Club or Members act of negligence.
Written to a Limit of **£1,000,000** any one incident
- ▶ **Personal Liability** insurance for all Day Ticket Purchasers plus Guests and other Visiting Anglers, in the event that they cause Third Party Injury whilst fishing on the selected Club waters only (no cover given for Third Party Property damage under this section). Written to a Limit of **£1,000,000** any one incident
- ▶ **Professional Liability** insurance specifically for Angling Coaches, Guides, Ghillies and the like, in the event that their professional abilities are questioned to the point that someone suffers physically or financially as a result of alleged wrongful teaching, guiding, advice etc. and they are found to be legally liable. Written to a Limit of **£1,000,000** in the aggregate over 12 months and on a Claims Made basis.
- ▶ **Cyber** cover in the event of hacking, unauthorised collection of electronic data, breach of confidence, infringement of the right to privacy, negligent transmission of a virus etc.–the list goes on and on. Written to a Limit of **£100,000** This additional cover will be included in the Public Liability wording as a sub section

NB Cover includes Inland Fishing from Boats as far as directly related angling incidents are concerned. However, the insurance offered specifically excludes any Marine Liabilities (cover available on an individual basis but provided on an individual standalone basis). The **MEAD** Cover excludes Firearms liabilities unless individually negotiated
